### PRIVACY NOTICE ON PERSONAL DATA PROCESSING THROUGH THE COOKIES

As MNG Airlines and Transportation Inc. ("MNG Airlines"), we value the protection of your personal data, so we expect you to show the same care. For this reason, it is very important for us that you read this text detailing which personal data we use for what purpose and clearly understand the obligations of MNG Airlines, who is responsible for the administrative and technical security of your personal data as "Data Controller".

# Why am I reading this text?

Article 10 of the Law No. 6698 on the Protection of Personal Data ("KVKK"), which entered into force on April 7, 2016 requires that the persons whose personal data is processed (used) (referred to as the relevant persons in the KVKK) to be informed by the "Data Controller" who uses this data. As a Data Controller, we have to prove that you, our guests, have been informed about your personal data we will process.

# What are your personal data used and in what ways are they obtained?

As MNG Airlines we collect your personal data with your visit to the website (expressed as "automatic" method in KVKK) in the presence of your explicit consent or for legal reasons to protect our legitimate interests.

Data on Process Security	Your IP address information	Your mentioned information is obtained automatically through your visit to our MNG Airlines website and for the legal reason that processing is mandatory for the fulfillment of our legitimate interests, provided that it does not harm your fundamental rights and freedoms.
Marketing Data	Information about your visits obtained through cookies (Google Analytics code proving that visitors are natural persons, your visitation frequency, duration and number of visits, web pages you visit)	Your mentioned information is obtained automatically through your visit to MNG Airlines website and in the presence of your explicit consent.

### What is the purpose and legal reason of your personal data obtained?

In the table presented below by MNG Airlines, the purposes of personal data processing carried out within the scope of the activity in which the Privacy Notice is issued are detailed. Each personal data processing purpose is matched with the categories of personal data and the relevant legal reason relating to the purpose.

# Are personal data transferred to others?

Within the scope of our activities carried out with cookies, your personal data can be transferred to developers and service providers whose servers are located abroad for the purposes of customizing MNG Airlines services for you and conducting marketing activities.

# What rights does KVKK give me?

KVKK allows you to control your personal data such as:

- (a) learn whether or not her/his personal data have been processed;
- (b) Request information as to processing if her/his data have been processed;

- (c) Learn the purpose of processing of the personal data and whether data are used in accordance with their purpose;
- (ç) Know the third parties in the country or abroad to whom personal data have been transferred;
- (d) Request rectification in case personal data are processed incompletely or inaccurately;
- (e) Request deletion or destruction of personal data and KVKK provides many rights including but not limited to these. You can find all of these rights and details in article 11 of the KVKK.

# How can I exercise my rights?

If you want to use the rights specified, you can submit your requests in writing (for example via a warning letter or a registered letter with acknowledgement of receipt) or by using a registered electronic mail (KEP) address or by means of secure electronic signature, mobile signature or using the electronic mail address that you previously presented to us and that is registered in our system.
